*Dr. Das* stated that based on the medical information he has reviewed, most of the complaints seem to be subjective.

*Mr. Jeffers* stated that police work is very strenuous and stressful and his treating doctor states that he can't work.

*Mr. Hyland* stated that he seldom missed work and he begin having chest pains, finally went to the doctor and they found a blockage in his artery and they did an angioplasty. He went through a brief history of chest pains thereafter and that he should avoid worsening his condition.

**Member Heredia** asked if the Court said that when a Department offers modified duty that they be very specific.

Mrs. Devencenzi said that the Department gave a generic description of a modified position; in this case it is with IA.

*Lieutenant Dale Morgan* stated there are many positions available within IA or personnel unit.

Mrs. Devencenzi stated that the job description does fit into the legal parameters, as he did state the specifics.

*Mr. Jeffers* said the problem here is that the different doctors have varying opinions and the Department should provide a description of the position duties to show to the doctors and that maybe a short continuance to the next meeting will suffice.

# POLICE & FIRE RETIREMENT PLAN Minutes of 7 September 2006

*Dr. Das* stated that Mr. McClanahan passed away due to complications from Lung Cancer and in his line of work he was exposed to smoke, radon, and asbestos.

**Chair Skeen** stated that Mr. McClanahan had several other medical problems and asked why those medical records were not included.

Dr. Das stated that he was not privy to that information.

*Mr. Boil* said that based on the presumptive cancer section of the Code presents industrial service-connected disability, if it is not clear from the evidence then he would ask for the Board to fully develop the medical record.

**Member Heredia** stated that he was present when testimony was given at the presumptive cancer hearing and he knows that they firefighters did not wear masks back in the 60's and 70's, so there is no question about gas exposure to Mr. McClanahan.

## Update on excess earnings benefit.

*Linda Hurley* stated that they just finished with their field work, as they were on site for three weeks, so they are wrapping up the information now. They will be providing a draft report to City Finance and staff should have their section done by mid-September and the CAFR can be done by the end of the month, so the audit is on track.

**Member Heredia** asked if there is a specific plan for what items they were prepared to audit and if there was any pressure put on the auditors to review something other than what was on their agenda.

Kevin O'Connell stated that there was absolutely no pressure from any sources, they did have an awareness of the other audit going on and they did look into it as far as if it would have any impact on the scope of their own audit, but there was no influence from any one. The work was done within their professional standards.
