Chair Skeen referenced the memo to City Council dated 12/18/08, authored by Mr. Crosby, asking if the Board reviewed the document; he also noted the request for information only asked for four items to be addressed, but there seemed to be additional information provided that was not required. Where did the additional information come from and why was in provided? He also noted the actuarial 5-year smoothing method, which is used to set the contribution rates takes into account the Plan losses. Although the Plan has been going through the difficult financial crisis, the long term strategy was not portrayed in the memo.

The Secretary stated he received directive from the Rules Committee to prepare the memo, which was originally request by the Mayor. The Board's Acting Chair and legal council received the memo prior to it being sent to City Council. The memo fully addressed the Mayor's questions. As noted, that the process of reallocation was initiated prior to the economic meltdown.

Mrs. Racy-Choy stated the 5-year smoothing mechanism mentioned in the memo has a trigger in place, so after a certain level of loss the smoothing stops. She agreed that Chair Skeen is correct that the long term performance should be the goal; however if you look at the last 10 years, the Plan had an average annual rate of return of 7.87% for the 10 year period ending June 30, 2008; and when you deduct manager fees, administrative expenses, and SRBR, the Plan earned a net rate of return of roughly 7.0% annually. When the Plan does not earn the target performance, which is the actuarial net rate of return of 8.0% annually, the funding ratio of the Plan decreases and the financial condition of the Plan deteriorates.

(M.S.C. Brill/Cortese) to approve. Motion carried 5-0-2.

#### OLD BUSINESS/CONTINUED-DEFERRED ITEMS

#### 8. Travel Audit compliance update.

Mrs. Niebla stated an informational memo has been provided. The priority recommendations have been completed with the exception of item 6, which is priority three, and Item 16, which is priority two. The Department has obtained samples of other Plan policies that will be forwarded to the Audit Committee for review. The City's final Travel Policy will also be forwarded to the Audit Committee.

Member Johnson stated the City's Travel Policy will be finalized in February, and training will be provided to all City staff, including DRS staff. Travelers will also be invited to provide feedback on the policy. The final policy should be ready to bring to the Board in March. He also suggested that the Audit Committee's work plan be discussed, and possibly the role of the Committee expanded.

### 9. Update on the soundness of the P&F Retirement's investment portfolio.

Mr. Alan Martin of NEPC stated that they are in the process of gathering the Plan's performance data in absolute terms, relative basis, and comparisons against other Plans. He discussed the market environment for 2008 and provided performance data of major asset classes as of the third quarter and year. He added that most of the indicies have declined. Over the last 12 months, the Fund experienced a gross investment loss of \$482.1 million, including a loss of \$249.4 million during the quarter. Total assets decreased from \$2.56 billion at the beginning of the quarter to \$2.35 billion on 9/30/2008, with \$37.6 million in net contributions. Over the past five years, the Fund returned 7.3% per annum, trailing the total fund benchmark by 0.1% and ranking in the 19<sup>th</sup> percentile of the Independent Consultant Cooperatives' Public funds Universe. As of 9/30/2008, the portfolio's one year return was -16.5%, trailing the total fund benchmark by 1.2%, and ranking in the 81<sup>st</sup> percentile of public funds. For the quarter, the Fund posted a -9.6% return, trailing the total fund benchmark by 0.8% and ranking in the 79<sup>th</sup> percentile of public funds. All asset classes were within policy ranges on 9/30/2008. Mr. Martin stated he has seen a number of recessions and normal cycles, but today is different as it is a global

deleverage in process. There has been too much leverage with the banks. In the subprime crisis a number of banks were overly exposed – the value of assets declined. The banks tried to sell the troubled assets, unfortunately the market had very little liquidity, and without a buyer the value of the asset depreciates. That same situation occurs repeatedly. It can only be resolved when a third party with capital purchases assets that are distressed.

Member Johnson suggested that we should consider performance based fees for managers. Also, part of the discussion the Board should have needs to include changing the open and closed amortization period.

Mr. Martin stated managers have a base fee and if they don't exceed the index they won't collect any additional amounts. It is not a good approach to use with managers because it creates a bias in favor of the market. If the Board wanted to pursue fee restructuring NEPC can assist, but the key is to set the right strategy.

Mrs. Racy-Choy stated the amortization period is an actuarial question and Segal will be presenting at the next meeting. An open amortization period takes the actuarial value of assets and liability and sets it at 30 years each year; however a closed amortization period is set at 30 years and each year the timeframe gets shortened.

Mr. Martin stated the Plans assets are under-diversified, but the Board has accepted his firm's recommendation to move the allocation to a more dynamic asset distribution. NEPC is well positioned to provide more due diligence since dynamic distribution is more complicated. Mr. Martin noted that the Plan has been nominated as Plan of the Year by IMN.

The Secretary stated as changes are done by the Board the policy has been modified.
