Ms. Dent reported to the Board that the request for Private Letter Ruling was filed with the Internal Revenue Service, but stated that the IRS requested withdrawal of Ruling request #3 and noted that the request was not an indication of a denial. Outside Counsel recommended continue to move forward with Rulings 1 and 2, but withdrawing Ruling request 3 per the IRS request. Ms. Dent noted that ruling request #3 could be filed separately at a later date if it appears that the IRS would be receptive to the request.
