### Keeping your account up-to-date!

ORS would like to remind members how important it is to keep your account up to date. We hear of far too many cases where personal information in a member's file was out of date and therefore, sometimes causes problems for the very loved ones the member hoped to benefit and protect.

It is important to note that when you change beneficiaries with the City as an active employee for the purposes of life insurance or other programs, it does NOT automatically update your retirement portfolio. Go to your MemberDirect portal and check your account to ensure you have reported such changes as:

- Marriage
- Divorce
- Death of a spouse, partner or child
- Birth or adoption of a child

While you are updating things, don't forget to make sure we have an active email address and phone number, too. They are the contacts we need to alert you of vital information.

### Need help buying fresh foods? Cal Fresh is Here!

The Cal Fresh program is available to help people get healthier, fresh foods on the table. Those who wish to participate must submit an application that will be reviewed for qualification based on household income and expenses. More than 100,000 Californians are participating in the Cal Fresh program. Hundreds of Santa Clara County restaurants and food stores accept Cal Fresh vouchers.

### **Congratulations to New Retirees!**

One of the highlights and great satisfactions each year here at ORS is helping City employees transition into a well-earned retirement during that popular season for retiring from about January through April. We work hard to help ensure that retirement applications are complete and correct, and that retirees can begin the next chapter of their lives secure in the knowledge that the benefits they worked hard for are in place and will arrive as expected. Preparing for retirement doesn't happen overnight. It's a process that should start well in advance of your anticipated retirement date. We recommend submitting an application about 2-3 months prior to your retirement date.


### Profile:

Has San Jose's Animal Care & Services got a deal for you! Right now, they urgently need loving adoptive homes for dogs. Stop by and meet the homeless dogs and cats of varied breeds and ages who just need a home and love. Doing so will help Animal Services care

for the sick and injured pets being brought into the facility every day.

As of this writing, adoption fees for ALL dogs over six months old are waived.

You can also foster a dog or cat, for as few as three weeks or as long as three months. All supplies and medical care are provided.

The shelter is open Tuesday-Friday, 10 a.m. to 6 p.m. Adoption hours are Monday from 12 noon to 4 p.m. and Tuesday-Sunday during regular business hours. Adoption applications are accepted until 30 minutes before closing.
