Mrs. Niebla stated a memo has been provided; Finance has provided the latest City Travel Policy which incorporates comments submitted by the Boards.

11. Update on the soundness of the Federated Retirement's investment portfolio.

Mr. Kumar stated a memo has been distributed for review. He calculated the unaudited returns as of 12/31/08, which was approximately -24.0%, compared to the S&P closing at -37.0%. Bonds did better at 5.2% since the index was mostly invested in Treasuries and the Plan's managers underweighted in Treasuries.

Member Loesch thanked staff for providing the comparables, as requested.

12. Acceptance of GRS' Report on Actuarial Valuation of Retirement Health Benefits as of 30 June 2007 (GASB 43/45) and authorization to forward on to City Administration.

Approval of the contribution of funding on behalf of beneficiaries of the Federated City Employees' Retirement System toward a Total Health and Disease Management ("THDM") service agreement with MedExpert International, to be executed by the City of San Jose and administered by the Human Resources Department of the City of San Jose, for the period February 1, 2009, through June 30, 2009, in an amount not to exceed \$26,000, and for the period of July 1, 2009, to June 30, 2010, an amount not to exceed \$66,000. There will be an additional option to participate in the extension of the agreement through June 30, 2011, subject to the approval of additional funds by the Board of Administration of the Federated System.
