PacifiCare Enrolled Retirees

Secure Horizons Medicare+Choice Plan is now contracting with Medicare to offer discounts on prescription drugs. The Secure Horizons Discount Drug Program is a Medicare-approved program that will help you save 10% to 30% on prescriptions, when you fill those prescriptions at PacifiCare's network retail and/or mail order pharmacies. The program will help you save money on prescription drugs that you would normally pay for out-of-pocket. These might include any Medicare-approved drugs not covered under the Medicare+Choice Plan formulary.

Effective June 1, 2004, Secure Horizons will automatically enroll all Medicare+Choice Plan members into this program. The new program will NOT replace or change your current prescription drug benefits or discount pharmacy benefits. It will only complement your existing coverage and mail-order discounts at no additional cost to you.

In order to get discounts under the Drug Program, you must use a retail and/or mail order pharmacy that is in PacifiCare's network of pharmacies. FEDERATED NEWS: The Retirement Board Recognizes Same-Sex Marriages

At the Federated Retirement Board's June meeting, the Board reviewed and discussed the Plan's treatment of same-sex marriages. At that meeting, the Board voted unanimously to recognize samesex marriages when they are legal in the county, state, or country from which the marriage licenses are issued. Consequently, the Plan will no longer make a distinction between heterosexual and samesex marriages. The Board has authorized the Plan to begin applying the same rules to same-sex marriages as those used for administering benefits for heterosexual marriages.

For your reference, the San Jose Municipal Code (SJMC) section 3.28.1460 defines 'Surviving Spouse' to be "the wife or husband to whom a member was married at the time of the member's death who survives the member's death, and none other". The Municipal Code also defines the eligibility rules associated with providing Medical (3.28.1950-1990) and Dental (3.28.2000-2040) benefits for members, their spouses, and surviving spouses. Please refer to these sections for specific eligibility rules.

Same-Sex Marriages -Notify Us of Your Nuptials

If you are an active Federated member and you would like to notify Retirement Services of your marriage, please forward a written notice along with a copy of your government certified Certificate of Marriage to:

We will place a copy of your certificate on file and update our pension administration system with your spouses' information. This information will be verified again at the time of your retirement.

Please Note: Retirement Services can only accept marriage certificates issued by government agencies and authenticated with the agency's stamped logo or seal.

POLICE & FIRE PLAN NEWS: The Retirement Board Considers Same-Sex Marriages

The Police & Fire Retirement Board reviewed and discussed the treatment of same-sex marriages at their June 2004 meeting. The Board identified concerns regarding pending litigation and courtrulings related to this issue and directed the Board's attorneys to provide a legal report to the Board for the August 2004 meeting. At that meeting, the Board will reconsider action regarding the recognition of same-sex marriages for the purposes of Police & Fire retirement benefits administration.

Know Your Benefits

Don't assume. If you are thinking about retirement, you will have the best chance at going out smoothly if you "study-up" on your retirement benefits. For example, did you know that for Federated members it's not just vesting that makes you eligible for Dental coverage? According to the Municipal Code, Federated members must meet all of the following requirements (Police and Fire employees have other eligibility requirements):

- You must retire directly from City service; and
- At the time of your retirement, you are enrolled in one of the dental insurance plans sponsored by the City; and
- At the time of retirement, you are entitled to credit for 5 or more years of service or eligible to receive a benefit that is equal to at least 37.5% of your final average compensation.

As a practical illustration, suppose that a vested member moves from a full-time benefited position to a part-time un-benefited position with the City. Shortly after, he or she decides to retire. Although such an employee would retain membership in the Federated Plan, that member would not be eligible for dental coverage at the time of retirement because they were not enrolled in one of the City's dental plans as a part-time un-benefited employee.

There are many nuances to the City's retirement systems. Please take the opportunity to learn what's out there by reviewing your plan's membership handbook and the City's Municipal Code. Both are accessible on Retirement Services' new website: www.sjretirement.com.
